In order to complete this Agreement of Purchase and Sale (APS), all purchasers must provide a valid mortgage approval. All mortgage approvals <u>must</u> contain the following information and **SHOULD** be emailed to <u>parkhaus@matrixdevelopments.ca</u>.

IF THE PURCHASER DOES NOT PROVIDE A MORTGAGE APPROVAL AS ABOVE

The Vendor requires a reference letter from the Purchaser's bank to include the following information along with documentation to support the purchaser's financial assets/net-worth:

7. Contact name and phone number of Bank Representative/Financial Advisor issuing the letter. The letter also needs to be signed by the Bank Representative/Financial Advisor.

Please take the Agreement of Purchase and Sale along with these mortgage approval requirements to the financial institution when making the mortgage arrangements. Please note that these items are all minimum requirements of the vendor.
